Timelines

The timeline for these awards would be similar each year, commencing the process at the start of the spring semester for work related to summer and fall (and upcoming, known spring work) and conclude at the final faculty meeting (or similar time) in the spring.

- Call for Award Nominations by second week in January
 - o First year = Monday, January 14, 2019
 - Nomination announcement distributed but will not be pushed until full faculty approval on Feb. 1 unless voice vote / vote suspension approved today (Nov. 30).
- Deadline for Nomination forms by second week in February
 - o First year = due Thursday, February 14, 2019
- Call for Nominees to submit supporting document forms by third week in February
 - o First year notices sent to nominees by Thursday, February 21, 2019

- Deadline for Nominee submissions of award forms by second week in March
 - o First year = forms due Tuesday, March 18, 2019
- Deadline for decision (announcement?) of Award choices and discussion with School Chairperson by first week in April
 - First year = winner choices discussed with chairperson/director by Thursday,
 April 4th
- Faculty and Staff Celebration Day (Name under discussion) by the third week in April
 - \circ First year = TBA

RESOLUTION 3:

Process

The committee agreed on a simplistic process to encourage multiple nominations, including self-nominations related to the awards. The process includes three steps:

- 1. Nomination form (self or colleague)
- 2. Nominee contacted for interest/agreement
- 3. Nominee contacted for supporting documentation

The nomination form will be a Qualtric-based form to include the following:

- 1. Nominator's name
- 2. Nominee's name
- 3. Award selection (drop down list)
- 4. Note of nomination

Please note: This note of nomination is a 250 word explanation giving basic advice and recommendation related to the award chosen.

After the nominee agrees to the nomination, each nominee will be asked to submit supporting material (no more than 2 pages) to outline and document the nomination. This could include, but not be limited to, abstracts, outlines and photo/videos.

The committee will then review the backup/supporting information and select winners to be approved by the chairperson/director of the Nicholson School of Communication and Media.

KEY IMPACT NOTE:

The committee recommends the recommendations and process celebrate simplicity. Because of the number of documents and evidence required by faculty throughout the year, this process should be seen as easy and celebratory instead of belabored. The committee wishes the tone of the process to always be communicated in a positive, celebratory feel embracing simplicity and ease of use and process.

RESOLUTION 4:

Award selection / physical pieces

The committee discussed the options of providing a basic crystal plaque to all recipients with an additional \$50 gift card or cash stipend.

Resolution 4.1: Should the faculty receive a plaque and gift card/money or money/gift card only (double the value)?

Both Gift Card only

Resolution 4.2: Approve purchase of perpetual plaque. The initial investment would be approximately \$2000 (\$200 for each large plaque with initial engraving costs). Subsequent engraving costs would be significantly lower (approx. \$500).



Policy and Planning Committee November 30, 2018

1.0 PREAMBLE

The fundamental premise of this document is that a relationship of mutual respect and trust should exist between and among those faculty who are serving as Nicholson School of Communication and Media (NSCM) administrators and those faculty whose activities are focused primarily on teaching, research, and service. Therefore, faculty governance should be collegial and reflect diverse points of view. At the same time, the governance process should be efficient and aim to achieve broad faculty participation in a manner consistent with the other responsibilities of the faculty and the mission of the School and University.

The School administration shall represent the interest of the School to the School faculty and staff and to the central administration, and oversee and allocate human, financial, and material resources of the School among the various programs and allied units comprising the School. In the spirit of collegiality, the faculty of the School shall be consulted (when practicable) prior to decisions impinging upon faculty governance and reserve the prerogative to comment upon, request clarification of, or suggest modifications and alternatives to any administrative action taken by the School.

9.0 NSCM BYLAWS HISTORY

The University of Central Florida was opened in the fall of 1968, as Florida Technological University. The Florida legislature changed the name in December, 1978.

The College of Arts and Sciences originally was created in 1980, representing a union of the College of Humanities and Fine Arts, the College of Natural Sciences, and the College of Social Sciences. The first Arts and Sciences bylaws were approved on April 14, 1981 and were last revised on March 24, 1998.

The College of Sciences was created in 2005 from a division of the College of Arts and Sciences into two colleges: one for arts and humanities and another for natural and social sciences. The Nicholson School of Communication was then stationed in the College of Sciences. The College of Sciences bylaws are based on the original Arts and Sciences bylaws document, and the Nicholson School of Communication's bylaws are based on the College of Sciences' bylaws. These bylaws were drafted in February, recommended by the director's advisory council to the regular faculty, and ratified in April, 2017.

On July 1, 2018, the Nicholson School of Communication and Media was constituted from what had been formerly known as the Nicholson School of Communication along with programs from the School of Visual Arts and Design (i.e., Film, Digital Media, and the Florida Interactive Entertainment Academy).

In the case of conflict between NSCM bylaws and any college level, UCF policy or procedure, the current Collective Bargaining Agreement between the Board of Trustees and the United Faculty of Florida Chapter at UCF the highest administrative policy or procedure will supersede.
